I acknowledge that The O-Run Series LLC (hereafter referred to as the Event) is an extreme test of a person's physical limits and carries with it the potential for death, serious injury and property loss. The risks include, but are not limited to, those caused by the off road course, rough and uneven terrain, the obstacle course that includes pushing, pulling, lifting, carrying heavy objects and climbing in some cases in excess of 25 feet without nets or safety harnesses. The risks also include those caused by the facilities, temperature, weather, wind, rain, condition of roads, condition of participants, equipment, lack of hydration, actions of other people including, but not limited to, participants, volunteers, spectators, Event officials, and Event monitors, and/or sponsors of the Event. I hereby assume all of the risks of participating and/or volunteering in this event.

I certify that I am physically fit, have sufficiently trained for participation in the Event and have not been advised otherwise by a qualified medical person. I hereby consent to receive medical treatment which may be deemed advisable in the event of injury, accident and/or illness during this Event.

In consideration of my application and permitting me to participate in this Event, I hereby take action for myself, my executors, administrators, heirs, next of kin, successors and assigns as follows: A) Waive, Release, and Discharge The O-Run Series LLC and/or Competitive Edge Functional Training for Athletes LLC (as hosts and/or presenters of Event), its owners, employees, volunteers, representatives, and agents, the Event holders, Event sponsors, and Event volunteers and landowners (hereafter referred to as Releasees) from any and all liability for my death, disability, personal injury, property damage, property theft or actions of any kind which may hereafter accrue to me; and (B) Indemnify and Hold Harmless the entities and persons mentioned in this paragraph from any and all liabilities or claims made as a result of participation in this Event, whether caused by the negligence of Releasees or otherwise.

I agree to allow my photo, video or film likeness to be used for any legitimate purpose by the event holders, producers, sponsors organizations and assigns. The Accident Waiver and Release of liability shall be construed broadly to provide a release and waiver to the maximum extent permissible under applicable law.
